

Notes:

- 1. This notification form shall be submitted by a taxpayer or special collecting agent without an address, residence, office, or business location within the prefecture who does not have an approved non-resident tax agent or is not exempted from appointing a tax agent under the provisions of the Wakayama Prefectural Tax Ordinance.
- 2. The tax agent shown on this notification form must live in the area under the jurisdiction of the prefectural tax office in charge of taxation on the taxpayer or special collecting agent.
- 3. In the boxes for "個人番号又は法人番号 (Individual or corporate number)", an individual applicant shall enter the individual number (defined in Article 2, paragraph (5) of the Act on the Use of Numbers to Identify a Specific Individual in the Administrative Procedure), and a corporate applicant shall enter the corporate number (defined in Article 2, paragraph (15) of the aforementioned act).

Leave the leftmost box blank when entering the individual number.
